PATHWAYS to Giving

GIFT of OVER \$300,000

supports young men through YWCA

When you mention the YWCA you don't often think they serve the men in our community. However, the YWCA of Hamilton is doing just that. They realize men also are victims of domestic violence and are providing services to support them. They also are working to combat domestic violence by providing support to young men while they are in high school. With the support of a donor at the Hamilton Community Foundation they piloted a program called Men of Honor.

Men of Honor is a strengths-based group model developed by One



Circle Foundation that empowers young men to find belonging, build assets and de-construct harmful masculinity beliefs on their journey toward becoming respectful leaders and connected allies in their communities. During the pilot year, seven groups were offered at Hamilton High and Fairfield High school. A total 62 young men went through the 19 week program and more were interested in participating.

"I had the privilege of facilitating the program and heard many stories of hardship and struggle of young men who are determined not to be owned by their circumstances overcome and commented excel." Aaron Simpson, volunteer Men of Honor facilitator. "I was thankful for the opportunity to be a constant for young men who are so well acquainted with turbulence while offering a listening ear, words of wisdom and encouragement."

Due to the success of the pilot program, the donor, who has chosen to remain anonymous, made a five year commitment to support the program so it can expand and continue to serve the needs of our young men.

Donor advised funds allow donors to address needs of the community

When a donor establishes their donor advised fund at the Hamilton Community Foundation they get the benefit of the Foundation's knowledge of community needs. When an anonymous donor started their fund they had ideas of what needs they wanted to support but not the organizations. Through discussion and research, the Foundation was able to connect them with several organizations that met their goals.

One organization was the YWCA of Hamilton. The donor was interested in supporting organizations that shelter fathers and children in need of safety from domestic violence, as well as outreach and education about domestic violence to young men. While the YWCA didn't have a program in place to reach out to young men, they knew this type of service was a great need. They were thrilled to have the funding and opportunity to address this need.

"This gift is a game changer for our organization. To have this opportunity to focus on combating domestic violence early by educating young men is humbling," said Wendy Waters Connell, Executive Director YWCA. "This generous gift enables us to impact the lives of more young men today and in the future."

Through the creation of the Men of Honor program and its success, the YWCA was thinking "outside the box" to not only work with the Foundation to address the charitable wishes of the donor, but also the needs of the community.

GIVING FROM COMMUNITY GRANT FUNDS

Hamilton High School Band - Sponsor a Sousa Program



Over the past nine years, the Hamilton High School Marching Band Program has more than doubled in size. With the band program growing by leaps and bounds, it has become difficult to provide the instruments and equipment needed, especially more expensive instruments like the sousaphone or marching tuba. Many of the current sousaphones owned by the Hamilton City School District are more than 20 years old and deemed beyond repair. The Hamilton High School Band Parents organization set out to remedy this situation by launching a "Sponsor a Sousa" program seeking support from the Hamilton community to purchase new sousaphones for the Marching Band.

"We are grateful that the Hamilton Community Foundation responded to the call for support and granted nearly \$30,000 for four sousa-

phones," said John Millard, President Hamilton High School Band Parents. "Based on our past experience, when performers are provided with quality instruments, the seriousness and performance quality among players also increased."

YEAR-END GIVING: Ways to Maximize Your Charitable Deduction

Have you given any thought to your year-end charitable gifts yet? Now is a great time for giving. When you're making a difference in our community. Here are ways to make the most of your year-end giving.

Bundling Donations

With the recent increase in the standard deduction, many donors are using advised funds to "bundle" charitable gifts for several years into one calendar year. This strategy allows you to exceed the standard deduction in one tax year, while using an advised fund to support your favorite charitable causes over several years.

Review your stocks.

If you'd like to make a year-end charitable gift, consider giving appreciated stock. Selling stock will incur capital gains on the appreciation, but if you gift stock, you will receive a charitable deduction for the current market value of the stock—just as you would with a cash gift. Such gifts are deductible up to 30% of your adjusted gross income and you can carry the deduction forward for up to an additional five years.

Add to Your Fund

If you already hold a fund with us, you may make additional gifts at any time. Contact us as soon as possible to learn how you can gift cash, stock, publicly-traded securities, IRA assets and even complex transactions like real estate.

Honor a Loved One

A meaningful way to show the community that you care during the holidays is to honor a friend or family member by supporting a cause that they held close to their heart. At the Foundation, many nonprofit organizations have established endowed funds to secure their future operations.

Giving to our schools – Partnering to remove barriers to educational success

Create a Better Educated Community is one of the strategic goals of the Hamilton Community Foundation. The Butler County Educational Service Center and the Hamilton City Schools have partnered with us to ensure educational success. Identifying barriers to learning is something our school partners are addressing through the Butler County Success Liaisons. Success Liaisons, now in all Hamilton schools, work to remove non-cognitive barriers to learning. The Foundation's Unrestricted Fund provides annual support to employ a Success Liaison in the Hamilton City School District.

Recently a gift of \$5,000 was granted from the Hamilton Community Foundation's Youth Philanthropy Committee to help provide personal care items. Many families are living in extreme poverty, and they depend on government-issued help for their weekly groceries. Government assistance cannot be used to purchase non-food essentials, such as personal care products and paper products. Families struggle to provide necessities, such as soap, shampoo, deodorant, toothpaste, laundry detergent and/or toilet paper. Consequently, many youth do not have access to these items.

The grant from the Youth Philanthropy Committee purchased these much-needed items for youth in the Hamilton City School District. The liaisons assembled summer care bags, containing these items, and delivered them to families. "Personal cleanliness and self-esteem go hand-in-hand. Our hope is to enhance the self-esteem of the youth by providing them with the tools needed to keep themselves clean and healthy," said Carie Wynn Success Program Supervisor. "We are thankful for the support from the Hamilton Community Foundation and Youth Philanthropy Committee."



en you make a donation by December 31 to the Hamilton Community Foundation, you aren't just giving money—

If you are planning for a charitable tax deduction this year but are undecided about which nonprofits to support, consider opening a donor-advised fund at the Hamilton Community Foundation. You can claim a deduction for contributions to your fund now even though distributions from the fund might be made in future years. A donor-advised fund can be set up in one meeting.

FRA Rollover

If you are age 70 ½ or older, you can gift up to \$100,000 per year directly from your IRA to the Hamilton Community Foundation to support or create a new scholarship fund, field of interest fund or a charitable organization endowment fund. By using your pre-tax IRA assets, your charitable gift costs you less. In

addition, IRA Rollover gifts can be used to meet your required minimum distribution and are not subject to income taxes.

Let the Hamilton Community Foundation do the legwork.

Working with the Hamilton Community Foundation gives you access to our extensive knowledge of the local nonprofit community and the broad charitable needs of our region—so you can stay informed about the organizations you support and the effect your giving will have on the future of our community.

WOMEN GIVING THROUGH THE WOMEN'S FUND

For more than twenty years, the Women's Fund has brought women together to raise funds from women to benefit women. Through the Women's fund, women at every economic level can be givers and make philanthropy a tool for change. "By pulling our funds together, we are making a difference and are excited that we have now granted more than \$200,000 and have more than 400 individuals donating to the fund," said Joan Witt, Women's Fund chair.

In 2019, the Women's Fund granted more than \$50,000 to several organizations. One recipient was Miami University E-Campus STEAM Studio. The grant provided scholarships to female campers to increase access to STEAM learning opportunities and exposure to the Miami University Regionals Hamilton campus.

"Through the funding from the Hamilton Community Foundation Women's Fund, we were able to reach out to young women in Hamilton and the surrounding areas and double, and sometimes triple, the enrollment of young women for our programs," said Carrie Chambers Coordinator of E-Campus Student Engagement.

The Robot Academy registration originally had four young women registered prior to the scholarship, but because of the scholarship, eight additional young women joined us for that week's program.

"The funding received from the Hamilton Community Foundation Women's Fund was a gift that will continue to impact the lives of its recipients. This generosity provided an opportunity to many girls, such as Briella, who was able to participate in STEAM Studio solely due to receiving the scholarship. The opportunities allowed her to not only explore her passion for science and art at the same time but pushed her outside of her comfort zone," commented Carrie. In the words of Briella's mother, 'her experience helped instill in her a sense of social confidence as she prepares to begin middle school."







Another recipient, Girls on the Run, received a \$5000 grant to support the program throughout the Hamilton City School districts.

"In the 5 years we have had the GOTR program at Brookwood Elementary we have seen the current and former participants become a family within the school. The girls grow together through laughter, open conversations, and working together as a team. GOTR is such a powerful program to help give our girls the tools to help them be successful as they continue their path through Hamilton City Schools and into their own life journeys. The grant money will ensure that our GOTR family will continue to grow!"
