#### Engel Family Donates Inclusive Playground to Morgan Township Park Project



The Engel Family, owners of Diamond Heavy Haul in Morgan Township, have created a fund through the Hamilton Community Foundation for the creation of an inclusive playground to the Morgan Township Community Park.

Named "Tonya S. Engel Memorial Playground," in honor of the late Tonya S. Engel, the playground incorporates carefully designed elements to accommodate children of all abilities and is set to become the first of its kind in the township. Features of the playground are inspired by Tonya, including her favorite color purple, a flower shade structure, and a custom camper play structure harkening back to her family camping trips.

Reflecting on the contribution, Mike and Kaylin Engel, said, "Mom loved kids and nothing brought her more joy than seeing them happy. We know this park would be something that she would want and is our way of remembering and honoring her spirit."

#### More than \$400,000 Granted to Local Organizations So Far this Year

The Unrestricted Grant Fund at the Hamilton Community Foundation makes is possible for the Foundation to award local grants throughout the year. With five grant cycles per year, organizations have the ability to request funds for programs once per year. Thus far grants have been awarded to the following organizations:

**StreetSpark Program** - \$90,000 over three years. StreetSpark is a public art program that encourages local art installations throughout the community.

**Fitton Center for Creative Arts** - \$50,000 for youth programming.

**Butler Philharmonic** - \$25,000 for the holiday concert and community outreach.

**Hope's Closet** - \$20,000 for a foster parent recruitment campaign.

Fairfield Community Foundation - \$25,000 to assist the Foundation with a community grant.

Ross Community Foundation - \$10,000 to assist the Foundation with community grants.

Animal Friends Humane Society - \$37,720 to assist with revamping the adoption kennel.

**GMV YMCA – Booker T Washington Center** - \$100,000 over 15 months to support programming.

**Inspiration Studios** - \$20,000 for the purchase of a large-scale printer.

**Ross Local Schools Choral Association** - \$20,000 to purchase new equipment.

**Lonely Entrepreneur** - \$25,000 to support local minority owned businesses.





#### Youth Make Great Impact in Hamilton

The Youth Philanthropy Committee of the Hamilton Community Foundation meets monthly throughout the school year to learn about needs in the community. The Committee is comprised of students from grades 9 – 12 from Hamilton, Ross, New Miami and Badin High Schools.

"It's great to see students from different schools interacting and collaborating with one another," says Katie Braswell, VP of the Hamilton Community Foundation and facilitator of the YPC program.

With the assistance of board member Susan Vaughn, Braswell oversees the monthly meetings and keeps the students on track for learning about needs in the community.

"Susan and I certainly have our responsibilities," says Braswell, "but the students really do the work of planning meetings, recruiting new students and planning volunteer opportunities for the group."

The culmination of each year is the awarding of grants to local organizations serving youth.

Congratulations to the 2023 YPC graduates, Chloe Christen from Hamilton High School,

Natalie Jansenn from Ross High School and Ava Sanders from New Miami High School. The 2023-2024 class of Youth Philanthropy Committee will begin meeting in September.

The Youth Philanthropy Committee has been making an impact for more than 15 years by teaching youth the importance of philanthropy and volunteerism. The YPC is responsible for making funding recommendations for grants from several Funds at the Foundation: Christopher Courtney Memorial Children's Fund, Butler County Children's Home Fund, the Exchange Club Fund, Melvin J and Mary Helen Hauser Memorial Fund, Charles and Elizabeth Heitsman Fund and the Albert Stuhlmueller Memorial Fund.

#### 2023 Youth Philanthropy Committee Grants Total \$30,175

- **Big Brothers Big Sisters of Butler County** \$5,000 for site-based mentoring at Riverview Elementary School.
- Fitton Center for Creative Arts \$5,000 for summer camp.
- **Girls on the Run** \$2,500 for entry fee for local girls to participate.
- Hamilton Living Water Ministry \$3,275 for summer camp.
- HOPEfull Pastures Therapeutic Farm \$2,650 for automatic watering system for livestock.

- **JEE Foods** \$5,000 for Miami University Regionals food pantry.
- Ohio State Extension Office \$2,750 for a youth food safety and safe cooking program.
- **Parachute:CASA** \$1,500 for gift certificates for advocates to take clients out to eat or for ice cream during their visits.
- Sleep in Heavenly Peace \$2,500 for supplies to make beds for children who don't have one.

## First LINKS Program is Time Well Spent



The inaugural Hamilton LINKS (Lead, Inspire, Network, Knowledge, Support) program has wrapped and its 16 participants agree the seven session curriculum was worthwhile and helpful.

John Guidugli, President and CEO of the Hamilton Community Foundation, created the Hamilton LINKS program with Dan Bates, Greater Hamilton Chamber of Commerce President, with three objectives:

- Sharpen leadership skills through interesting information and activities
- 2. Tackle relevant topics through discussion with other leaders
- 3. Build a strong cohort creating trusted relationships among Hamilton leaders

Sessions were inspired by participants themselves, helping to make the program topical.

Brett Kirkpatrick, President and CEO of Community First Solutions says it was an amazing experience.

"There are a lot of 'leadership programs' available," he says, "but they are generic in nature and they don't always use real world or regional factors within their model. The LINKS is about so

much more than leadership from a book – it's networking with other local leaders while talking about issues we are having right here in Butler County."

"One of the more interesting sessions dealt with how to have

difficult conversations," says John Guidugli. "This was a concept that seemed to resonate with everyone, and as folks shared their experiences and suggestions I felt a sense of empathy and appreciation from everyone."

Aside from addressing tough and/or relevant topics the pro-

gram created a camaraderie amongst the participants.

"The Hamilton LINKS program yielded several long-lasting relationships that have served as a resource for my business needs as well as allowed me to form personal relationships," says Marni Durham, Butler Tech Assistant Superintendent. "I am truly grateful for the experience.

## Women's Fund Increases Scope



The Women's Fund at the Hamilton Community Foundation was

created in 1997 by Joan Witt and Karen Whalen to address the needs of women and girls in the community. Through the years loyal donors have helped to make the Women's Fund a successful resource for organizations addressing the needs of local women.

"There is no shortage of need in this community for women struggling with issues ranging from poverty and drug addiction to homelessness and the threat of eviction," says Katie Braswell, VP of the Hamilton Community Foundation. "The Women's Fund Committee is focused on addressing any and all of the challenges our women and girls face."

The Women's Fund has poured more than \$280,000 into local organizations that serve women.

"This community is fortunate to have some incredible organizations working diligently and passionately day in and day out to provide a ladder of support on which women can climb out of their circumstances," says Niki Motley, Chairperson of the Women's Committee.

The Women's Fund Committee is comprised of Motley, Liz Hayden, Nancy O'Neill, Founder Joan Witt and Carrie Zancan. In 2023 the Committee decided to expand their focus to include a new initiative, Women Inspiring Philanthropy (WIP). WIP will usher 15 local women through a 10 month program geared toward encouraging female leadership in local organizations.



- More than 30 organizations have received grants from the Women's Fund, many have received more than one.
- **62 grants** have been awarded since the Fund's creation.
- More than \$280,000 has been awarded through the Women's Fund.
- Some of the organizations the Women's Fund have supported are YWCA, Support to Encourage Low-income Families (SELF), Women Helping Women, Girls on the Run, GirlsCan Program.

"We have an incredible pool of local women who love and are passionate about this community," says Motley. "We want to provide these women with the tools and empowerment to strive for a seat at the head of the board table for local organizations, particularly organizations with a female focused mission."

The first WIP session will begin in September of 2023. Each month the ladies will meet for a couple of hours in the afternoon to learn about local organizations, leadership opportunities and information about how to engage in leadership positions.

"Women are instrumental in the philanthropic sector," says Braswell. "They are proven to give more and more often. It just makes sense that they would be taking on leadership roles in charitable organizations."
