Dick & Mary Law

In retirement the IRS requires you to withdraw a certain amount (a required minimum distribution) from your IRA each year whether you need the funds or not, and you normally pay income tax on every distribution. However, if you are 70 1/2 or older, you can make a gift directly from your IRA account to the Hamilton Community Foundation with no tax consequences.

Dick and Mary Law began using their required minimum distribution to establish a scholarship fund in 2013. "We knew we wanted to establish a scholarship fund and by using the charitable IRA rollover option it was an easy way to give," said Mary. "Now it is just a habit that we do to build our scholarship fund for the benefit of the young people in the community."

At the end of 2015, Congress passed the law that allowed gifts made directly from an IRA (up to \$100,000 per person per year) to a qualified charity. By utilizing this option, the funds are not reportable as taxable income and qualify toward your required minimum distribution which can lower your income and taxes. Giving through your IRA offers several benefits. You reduce your taxes, it allows you to set up a fund to benefit one or more organizations you care about, and you feel good knowing that you were able to make a major gift from your IRA.

NEW TAX LAW ENHANCES CHARITABLE GIVING

When Congress enacted the most comprehensive tax law changes in December 2017, the charitable deduction was the only deduction not limited and some cases it was expanded.

In the past, gifts of cash could reduce tax on up to 50% of your adjusted gross income (AGI) each year. This amount was increased to 60% under the new law.

Donor Advised Funds

A Donor Advised Fund may be a great giving vehicle for your charitable gifts. With a Donor Advised Fund you can make your gift to the Foundation when it makes the most sense for you – for tax purposes or for convenience. Once you make the gift to the Donor Advised Fund, you receive the full tax deduction and you make gifts from the fund to your favorite charitable causes.

Gifts of Stock

With the strong performance of the market, it may be particularly advantageous to make gifts of stocks.

If you own stocks, mutual funds or other securities that have increased in value, and you have owned them for more than a year, it can be wise to use them to make charitable gifts.

The new law retained the tax benefits that benefits making a gift this way. You may still claim a deduction for their full market value, not just the amount you paid, and you do not have to pay capital gains tax if you gift them to charity.

This opportunity is available to everyone, whether or not you itemize deductions.

Whatever option you are interested in, check with your tax advisor to determine what would be best for you.




FOUNDATION NOW PROVIDES Options for Recurring Gifts

Recurring donations allow you to give more with less effort. When you receive your monthly donation receipt you'll remember your commitment and passion for giving back.





TALENT ATTRACTION PROGRAM SCHOLARSHIP

Draws Local & National Media Attention

The impact of the Hamilton Community Foundation is evident throughout our community. Education continues to be an area of focus making a difference in the lives of our residents. In the past 60 years, over \$13 million dollars in scholarships have been awarded to more than 3,000 students. The Foundation's support of education and community quality of life initiatives are key elements of the strategic plan. A unique way to help grow the educational levels of Hamilton's population and to increase residents in the Urban Core neighborhoods, the new Talent Attraction Program (TAP) Scholarship was established.

The TAP Scholarship is what is known as a "reverse scholarship" where recent graduates will receive assistance with stu-



dent loan debt. To be eligible, students must - Have graduated within the last 7 years from a STEAM program (Science, Technology, Engineering, the Arts, or Mathematics) - Not currently living in Hamilton BUT with plans to move to or live in the Hamilton's Urban Core. - Must demonstrate employment within Hamilton/Butler County. Successful applicants may receive up to \$5,000, \$200 per month for 25 months

"This unique scholarship is one way the Foundation can continue to support the revitalization efforts happening in Hamilton, said John Guidugli, President & CEO. "While we will continue to support our high school graduates with traditional scholarships, it is our hope they will come back home to further the growth in our community."

Scholarship Funds provide a tangible link to the future. The gift of education that a scholarship bestows benefits not just the student, but the community as well. Whether a lasting memorial to a person or to meet current charitable needs, a scholarship fund provides access to educational opportunities for a wide variety of students --- from pre-school to post-graduate and now for the new Talent Attraction Program Scholarship. The Foundation offers flexible, affordable options for you to realize your charitable intentions.

How it works:

• You make a gift to the community foundation—cash, appreciated stocks, real estate, or other assets. Minimum gift to establish a scholarship fund is \$10,000. However, you may build your fund to the minimum size over five years.

• Receive tax benefits in the year your gift is made.

• Determine the name of your Scholarship Fund. This could be in the name of your family or business, or in honor of any person or organization you choose.

"Through my four years in this group, I have had amazing opportunities to meet hundreds of people who work everyday, in many unique ways, to benefit our community and the people in it," said Kenny Pendergest, chair of YPC Needs Assessment committee. "I am going to miss YPC but I know that, wherever I end up, the lessons learned from this amazing group will continue to help me throughout my life."

Kenny is undecided on the college he will attend but plans to study Civil Engineering.

Over the course of my time serving on Youth Philanthropy Committee I have learned so much about the Hamilton Community and the people in it. Before serving on YPC I had little variety in my community involvement. YPC has given me the opportunity to expand my experiences into all sorts of new avenues and grow my skills as a servant, leader, and citizen. I intend to capitalize on these skills in the future by giving back to the community, " said Wyatt Grimm, YPC Recruitment Chair.

Wyatt plans to attend Hocking College in Nelsonville, Ohio to double major in Natural Resources Law Enforcement and Wildlife Management.
