The Women's Fund is a Field of Interest Fund that supports programs and services that address the needs of women and girls in the community.

According to Fund Co-Creator Joan Witt the Fund was established to help women in the community succeed financially, mentally and physically. The second goal was to utilize the Fund to promote female philanthropy.

"We've supported everything from pre-natal care to support groups at nursing homes," says Joan. "At one point we created calendars because we realized a lot of women aren't raised to live by any structure."

The Women's Fund has poured more than \$280,000 into female related causes in the community since its inception. The Fund continues to grow through targeted fund raising.


BENEFITS OF A FIELD OF INTEREST FUND

Connecting personal values to high-impact opportunities | By establishing a Field of Interest Fund, you can target your gift to address needs in an area important to you. Then, our board awards grants to community organizations and programs that are making a difference in the area you select.
