


Fairfield Community Foundation Scholarship Spotlight



not-for-profit organization, you can do so by setting up a designated fund. Your gift to the Community Foundation to establish such a fund will mean that you can rest assured that your gift — even 50 years from now — will be used as you desire. The Fairfield Community Foundation Board will ensure that the funds are used by that organization for the purpose you intend.

Field of Interest Funds When you set up a field of interest fund, you provide funding for an area of interest that is particularly important to you. For instance, if you want to support projects for recreational needs in Fairfield or art projects in Fairfield Township, your fund can be set up to do just that ... forever.
