The Ross Community Foundation is launching their **“Give Where You Live”** campaign to support the Ross community today and in the future.



The goal of the campaign is to create an endowment fund of \$500,000 in which the Ross Community Foundation Board of Trustees would grant to the community. Through the unrestricted Community Impact Fund, grant applications would be accepted from nonprofit organizations and other community quality of life projects in the Ross community. To ensure the fund would be here for the community in perpetuity, only 4% would be granted annually.
