Unrestricted Funds account for approximately 12% of the Hamilton Community Foundation Fund pie. That 12% is critical to the Foundation's ability to pour dollars into the community where they are needed most.

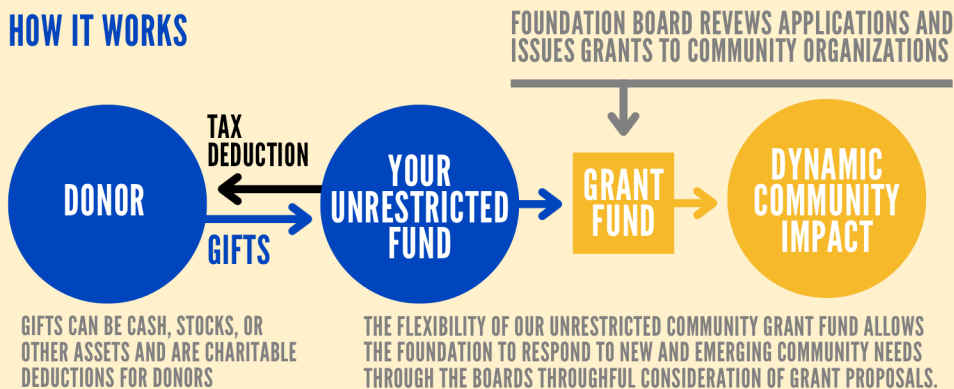
